Well summer is finally upon us! This winter your Board was very busy working on insurance and legal issues, as well as another revision to our By-Laws. We are now happy to be working on something a little more fun – the summer BBQ - which is set for Saturday, August 4, 2007. And we are gearing up for the fall meeting and election of Board members. Your mailboxes will soon hold more details about these activities.

During the winter months our insurance policy was transferred to Hart Insurance, a local agency that has provided a superior level of customer service. We now have a new underwriter who specializes in homeowners associations, and we have added Board of Director Insurance. We also consulted with an attorney who reviewed the Association's documents and policies. The attorney, who also specializes in homeowner associations, commented that our association is running better than most he has seen. His overall assessment is that we are in great shape. The attorney also reviewed the proposed By-Laws revisions which were recently passed at the spring meeting and are now in effect.

At the fall general meeting we will hold elections for Board positions. It is very important that we fill all positions in order to be able to make decisions representative of the entire membership. I ask that you seriously consider running for a position, and I will send out a flyer with more information later in the summer. If you have any questions and/or might be interested in running, please contact me or any board member.

The Association is in good financial shape, while coming off the heels of last year's beach park project. We are working within budget, but as you know from paying your own bills, everything is getting more expensive. The only reason the Board can work within the current budget is because of the handful of members who continually volunteer their time, effort and often materials. This saves the Association a lot of money. Without these volunteers the Association would not be able to operate under the current rate of dues being collected.

Beach & Lake Commissioner's Report

It's hard to believe that we are nearing the mid-point of our summer season. We have made several additional improvements to the property worth discussing.

We held our second annual beach cleanup day on May 19th and once again the rains came. Despite the bad weather we had a good turnout, and we got quite a few things accomplished. New plants and mulch were added in the park area and at the bottom of the beach steps. We also graded the area around the basketball court and planted grass that is coming in nicely. The sprinkler systems were turned on and we replaced some pipes leading to the shower that burst during the winter months. In addition, the bluff (which was recently trimmed back) was cleared of bottles and other debris, and the entire area was raked and prepared for the summer. Thanks to our volunteers, and some donated materials, all of this work was accomplished for less money than our budgeted spring cleanup by the landscaper (which we canceled). Once again, we would like to say a special thank you to Tom Liebler for donating his time and special talents to help maintain our property.

In response to a member vote last fall, the basketball rim and backboard was replaced with a clear acrylic backboard which looks better and should stand up to our weather conditions. This project came in at \$150 under budget.

We have had two private parties at the beach this year and both went extremely well. In both cases the property was left in the same (or better) condition than it was in before the party. It is great to see the property being utilized by our homeowners.

One upcoming improvement is the addition of a paver walkway through the park entrance gate. This project will cost \$1,200, but this entire cost was offset with the second paver fundraiser held this past spring. So in the end, there is no impact to our budget for this capital improvement. A contractor has been selected, and work should be completed by the end of July. We will not close the park for this construction as the job is fairly small, but please be careful when visiting the park and contractors are on site and please make sure children are supervised at all times.

The fourth annual SSBPOA Beach Party is scheduled for Saturday August 4th. More information will follow, but please save the date.

As always, if you have any suggestions on how we can improve the safety, appearance, or enjoyment of our common properties please bring them to our attention. All suggestions will be discussed by the board for possible implementation.
